# ORDER No. 51

# of the Rector of the Nicolaus Copernicus University in Toruń

of 26 February 2021

# on preventing the spread of SARS -CoV-2 among community members of the Nicolaus Copernicus University in Toruń in the period from 1 March to 30 June 2021

Pursuant to art. 52.3 of resolution No. 37 of the Senate of the Nicolaus Copernicus University in Toruń of 16 April 2019 - the Statutes of the Nicolaus Copernicus University in Toruń (Biuletyn Prawny UMK of 2019, item 120 as amended) in connection with the Regulation of the Council of Ministers of 21 December 20209 on the establishment of specific restrictions, orders and prohibitions in connection with the state of epidemic (Journal of Laws 2020, item 2316 as amended)

# it is ordered as follows:

# Article 1

The following rules shall be introduced to prevent and counteract the spread of SARS-CoV-2 virus among members of the community of the Nicolaus Copernicus University in Toruń, hereinafter referred to as the "University".

# Article 2

- 1. The University buildings shall be open to employees, doctoral students, students and participants of other forms of education, as well as to tenants of the premises located in these buildings.
- 2. Specific rules for the use of the University buildings and their preparation for users are set out in annex 1.

# Article 3

- 1. Domestic and foreign official outgoing visits of academic teachers, doctoral students, and students of the University and incoming visits of domestic and foreign visitors to the University shall take place with the consent of the dean, the director of the doctoral school or the head of the organisational unit respectively and in compliance with sanitary requirements.
- 2. Domestic and foreign official outgoing visits of employees who are not academic teachers shall take place with the consent of the chancellor or vice-chancellor for Collegium

Medicum - in the case of administration and servicing staff, or the head of an organisational unit - in the case of engineering and technical staff and librarians in which the employee is employed, and in compliance with sanitary requirements.

#### Article 4

- 1. Conferences, concerts, exhibitions, sports competitions and other events organised by the University shall be held in accordance with the requirements arising out of separate regulations.
- 2. The rules and scope of activities of the University Sports Centre other than teaching activities, approved by the competent vice-rector, are set out in annex 2 to the order.
- 3. The rules and scope of activities of the Collegium Medicum Centre for Physical Education and Sport, approved by the competent vice-rector, are set out in annex 3 to the order.
- 4. The rules and scope of activities of the Academic Centre for Culture and Art "Od Nowa", approved by the competent vice-rector, are set out in annex 4 to the order.

## Article 5

- 1. The University Library shall operate pursuant to the requirements arising out of separate regulations.
- 2. The rules and scope of activity of the University Library approved by the competent vice-rector are set out in annex 5 to the order.

## Article 6

- 1. The Nicolaus Copernicus University Archives shall operate pursuant to the requirements arising out of separate regulations.
- 2. The rules and scope of activity of the Nicolaus Copernicus University Archives, approved by the competent vice-rector, are set out in annex 6 to the order.

#### Article 7

- 1. Only students and doctoral students and participants of other forms of education from abroad may be accommodated in student houses.
- 2. No more than two persons may be accommodated in a room in a student house unless they run a shared household.
- 3. Accommodation in student houses shall only take place by prior appointment with the administration of the student house.
- 4. Visitors are not allowed in student houses.
- 5. Specific rules for the use of student houses are set out in annex 7, which was agreed with the student and doctoral student government and approved by the competent vice-rector.

# Article 8

- 1. Resignation from the residence in the student house shall take effect on the date of submitting the request of the said in writing.
- 2. In the event of vacating the student house, the rate for accommodation shall be reduced in proportion to the period of residence in the student house so that:
  - 1) residents who vacated the student house by the 15th of the month shall pay half of the monthly rate for their stay in that month;
  - 2) residents who vacated the student house after the 15th day of the month shall pay the full amount for their stay in that month.
- 3. The settlement of the reduced fee and the return of the overpayment shall take place in the month following the settlement period.

#### Article 9

- 1. Employees, doctoral students and students may report any information and questions concerning the functioning of the University in an epidemiological emergency to <u>koronawirus@umk.pl</u>.
- 2. Any information to third parties on the functioning of the University with regard to this order shall be provided by the Nicolaus Copernicus University Press Team (*pl. Zespół Prasowy UMK*) exclusively.

## Article 10

The organisation of education at the University is regulated by a separate order of the rector.

#### Article 11

The Chancellor, by way of an order, shall specify the specific principles of the functioning of the University administration and the manner in which the engineering and technical staff, servicing staff, and librarians shall perform their duties during the period of limitation of the functioning of the University in connection with preventing, counteracting and combating of COVID-19.

#### Article 12

In all matters not regulated in this order, decisions concerning the functioning of the University shall be made by the rector.

#### Article 13

The following orders shall be repealed:

- order No. 188 of the NCU Rector of 15 September 2020 on preventing the spread of SARS -CoV-2 among community members of the Nicolaus Copernicus University in Toruń (Biuletyn Prawny UMK of 2020, item 309);
- 2) order No. 228 of the NCU Rector of 19 October 2020 on preventing the spread of SARS -CoV-2 among community members of the Nicolaus Copernicus University in Toruń in the red zone (Biuletyn Prawny UMK of 2020, item 367 as amended).

Article 14

The order becomes effective as of 1 March 2021.
