



Annex No. 1 to the regulations: Instructions for calculating flat-rate funding costs

1. Number of days

The number of days of the foreign internship is predetermined and is 21 days for NCU students, and 28 days for NCU doctoral students and foreign doctoral students (including travel). In the case of students traveling to conferences abroad - a maximum of two days for travel (one day for departure and return) may be added to the actual number of conference days (if the participant left their place of residence the day before the conference began and returned the day after it ended).

In the case of participation in conferences and schools organized at the Nicolaus Copernicus University, the number of days (including two additional days for departure and return, if necessary) is as follows:

- 14 days I-HOW JWST Hands-On Workshop for Central and Eastern Europe 2025,
- 7 days per Molecular Excited States (MolEx) Workshop,
- 7 days per Plant-microbial interactions in saline areas,
- 6 days per M3-S "Applied polymers, nanomaterials, membranes, and composites".

Additionally, participation in a school preparing for the Academic World Team Programming Championships (ICPC) lasts 11 days (including two additional days for travel).

2. Stipend amount

The amount of the stipend depends on your status - it is PLN 75 per day for undergraduate and graduate students, PLN 125 per day for PhD students, and PLN 250 per day for foreign scientists.

3. Maintenance costs

Living costs depend on the country in which the mobility takes place. We calculate the daily rate according to the table:

4. Travel costs

Travel expenses depend on the origin (for international students and doctoral candidates coming to UMK) or destination (for UMK students and doctoral candidates) of the mobility. The amount to be added to the final result can be found in the table below.:

5. Calculation of total funding:

Total funding = Number of days * (Stipend amount + Maintenance costs) + Travel costs

- When applying for funding to attend an international conference, UMK students can include the conference fee (in a separate section) which will be reimbursed based on actual costs.
- In the case of conferences and workshops at the Nicolaus Copernicus University, the costs of conference fees are not financed and participants cover them themselves.
